Proposed Motion to UBCM on Administering, Resourcing and Expanding Universal Childcare From the Early Learning and Childcare Council in Oceanside (ELCO)

Delegation Submission

Carol O'Connor from Early Learning and Childcare Council in Oceanside spoke in support of the motion and provided some background information.

It was moved and seconded that the Board direct Staff to submit the following resolution to the Union of British Columbia Municipalities (UBCM) for consideration at the 2023 UBCM Convention:

WHEREAS the Ministry of Education and Child Care is responsible for B.C.'s \$10/day childcare program, and Child Care BC's growing system of universal childcare has been life-changing for families, with demand far outstripping supply;

AND WHEREAS the current grant-based process to expand universal childcare relies on grant applicants to coordinate all aspects of design and implementation, and local and Indigenous governments and nonprofit organizations often lack the resources to successfully manage this process in accordance with UBCM-funded childcare needs assessments and action plans:

THEREFORE BE IT RESOLVED that while the Province continues to rely on individual grant applicants to plan and develop child care expansion, that instead, the Province provide multiyear funding to local and Indigenous governments and nonprofit organizations to support resources to coordinate this process: AND BE IT FURTHER RESOLVED that UBCM urge the Ministry of Education and Child Care to replace the current grant-based application process with a systematic expansion of universal childcare that upholds UNDRIP obligations and supports the involvement of, but does not rely on, local and Indigenous governments and nonprofit organizations to coordinate design and implementation.
