#### Gabriola Land & Trails Trust Update for POSAC June 17, 2019

#### Invasive Species Control

For the past several years, Gabriola Land & Trails Trust (GaLTT) has joined forces with the Gabriola Lions Club in efforts to control the spread of Scotch broom in Drumbeg Provincial Park. Beginning last year, we began to engage the entire Gabriola community in cutting "broom in bloom" throughout the island, included work in Rollo McClay Community Park and Coats Marsh Regional Park. This year, the annual Drumbeg broom bash was held in late April, and several neighbourhood cuts were held throughout May. In addition, Island organizations were encouraged to adopt a patch of broom for action. About 12 different groups participated. The Lions Club completed the island-wide pick of cut broom up on June 1<sup>st</sup> and delivered it to a mid-island property for disposal. Broom has now formed seed pods, so action has ceased until next year. We'll switch our volunteer efforts to pulling Tansy ragwort later this summer and will also continue our monitoring and control of a nasty patch of giant hogweed on the south part of the island.

Invasive species are a growing threat to Gabriola Island and require a sustained and concerted effort to control their spread. The GaLTT Board is currently discussing the desirability and logistics of forming a separate Invasive Species sub-committee or encouraging the formation of a separate invasive species organization on Gabriola Island.

#### Accessibility Survey

During March and April, GaLTT invited Gabriolans to complete an Accessibility Survey in order to assess the interest and need for improved access to island trails and beaches. We will use the results to consult and work with the RDN and Provincial Parks to improve access where it is most needed for those with mobility or sensory difficulties. More than 200 surveys were completed and the results are currently being analyzed.

#### Conservation Covenants

GaLTT currently holds two conservation covenants on Gabriola Island and is the local agency authorized to monitor a third covenant held by American Friends of Canadian Land Trusts. A conservation covenant is an agreement between a landowner and a covenant holder, the purpose of which is to conserve the property in its current state in perpetuity, usually for environment reasons. The covenant holder's major responsibility is to inspect the property at least once per year to ensure that no breaches of the agreement have occurred. GaLTT completed annual inspections of two of the properties in May and plans to monitor the 3<sup>rd</sup> property in June. After thorough discussion and reflection, GaLTT recently declined an offer to hold a conservation covenant on the Gabriola Commons property.

#### 707 Community Park Signage

GaLTT is currently cooperating with the RDN to improve signage in the 707 Community Park. Our volunteer crews recently installed 48 new posts at unmarked trail intersections and will assist with installation of numbers and signs if needed. In our opinion, the project will make the expanded park safer and more user-friendly. Trail-building is not part of the current signage project.

#### Map Project

GaLTT is currently in the final stages of publishing a new edition of our popular trail map. There have been several new trails built on public and private land (trail licences) since our last edition was published in 2016. The new map will feature a large-scale insert map of the expanded 707 Community Park with trail names and numbered post locations.

#### Trail Building and Maintenance

GaLTT continues to maintain existing trails and build new trails where opportunities arise. We recently re-routed a trail in Haven Woods at the owner's request and built a new trail on the undeveloped right-of-way between Church Street and Tin Can Alley. GaLTT recently received a grant from the Gabriola Recreation Society to upgrade the trail

between McDonald Road and Peterson Road. GaLTT has also been contracted by the Islands Trust Conservancy to continue with trail improvements in the Elder Cedar Nature Reserve in 2019.

#### Community Engagement

For the past several years, GaLTT has organized an annual "end-to-end" walk for interested Gabriolans and visitors. The walking route mostly follows the wonderful network of interconnected island trails. This year's event was held on June 2<sup>nd</sup> and was promoted as an "across the middle" walk. The new, 13.5 km route included sections in Joyce Lockwood Park and several trails in the 707 Community Park, including trails in the newly acquired parkland. The final destination for the 53 participants was the Gabriola Golf Course for a cold beverage of choice.

Several community programs are planned for the summer season. A forest bathing walk and rock hound (geology) event will be held in July and a night walk and night cycle are planned for August. GaLTT will continue to have a table at the Farmer's market each Saturday throughout the summer.

Representatives of the McConvey Road Paving Society have been granted a ten-minute presentation at the June 17 POSAC meeting for Area B regarding the chip-seal project on McConvey Road, part of which runs between Cox Community Park and Descanso Bay Regional Park. In advance of this, the Society would like to enlighten the members of certain aspects of the project and the resulting benefits to all.

As you may know, each property owner along McConvey Road (with the exception of RDN and two non-participants) has contributed \$4,300 towards chip-sealing this road. **Of this road, approximately half the length lies between the two parks.** Each property owner, regardless of the length of their frontage, contributed the same amount. Should RDN be able to see their way to cover our shortfall (resulting from non-participants) and make similar \$4,300 contributions for each park, our Society would then be able to move forward this summer. Costs have already greatly inflated since last year and we would like to stop this from happening further.

Here are just some of the benefits accruing to the parks and RDN.

- eliminate most of the dust flowing into the campground
- eliminate the chemical exposure to the vegetation and forests adjacent to the park portion of the road
- significant improvement to the road surface between adjacent parks (primarily paid for by residents of McConvey Road)
- eliminate the surrounding heavily laden dust on the ground-cover and treed canopy that currently prevents or reduces necessary photosynthesis
- Irrespective as to whether the road is part of the park, this road provides good access to several of the wonderful public Galt trails within the park that McConvey

residents helped create

• Much improved air quality for hikers on these trail and residents alike A final area of concern is the lack of signage on McConvey Road. perhaps the RDN can work with MOTI to request for McConvey Road some much needed signage including:

- sign indicating road is a dead-end road
- sign indicating road is narrow and windy
- caution sign regarding pedestrians and cyclist on the road
- deer crossing sign, since there is a high number of fawns and does there
- sign at the entrance, noting Cox park is to the right and Regional to the left

Funding is always an issue (as it certainly is with our Society). To mitigate part of this, the following avenues could be considered:

- Potential eligibly for various federal/provincial grants available for environmental objectives.
- Surplus funds may be "found" in existing grants.
- Although it is understood that budgeting has long been complete for RDN's current fiscal year, there may be the possibility of additional funding towards such a worthwhile and imminent project

We look forward to discussing these matters with you on the Seventeenth!

#### Coats Marsh RP and the Potlatch Density Additions (Coats Marsh East and 707 CP SW)

While pleased that Gabriola has recently acquired new parkland, namely Coats Marsh East (W½ of NE¼ Sec. 10 except remainder) and 707 SW (SE¼ Sec. 13 except.. and SW¼ of Sec.14), I am rather disturbed that management planning for these new areas appear to be going ahead without any opportunity that I am aware of for public or even GaLTT membership input. This is despite the fact that the current management plans for the 707 CP and Coats Marsh RP will be shortly up for renewal, and that the Islands Trust LTC is actively considering creating a new P4 zone which will give them a tool to designate areas where the needs of wildlife have absolute priority. The Coats Marsh RP Management Plan in particular very badly needs up-dating to incorporate new knowledge about the ecosystems there and the parks hydrogeology.

It is to be regretted that it is not possible administratively for the Coats Marsh East land to be integrated with the existing Coats Marsh RP when having an administrative boundary separating the east shore of the *marsh* and the catchment area of the *marsh* from the rest of the *marsh* is going to create problems in an area that is so obviously ecologically integrated.

Exactly how it is intended to manage usage of any trails that cross seamlessly from the new lands into Coats Marsh RP is unclear. Simply making all of the new lands a part of the 707 CP, and even

contemplating new trails into the Coats Marsh RP from the 707 CP, would I submit run a grave risk of weakening the stated current goal of Coats Marsh RP management as identified by the Ecological Gift's program, the TNT/RDN Lease Agreement, and community consensus, to give environmental conservation priority, and to make human access to the park property a secondary consideration. Coats Marsh is I have no doubt one of the properties that the Islands Trust would have in mind if the P4 zoning tool comes into being.

I would respectfully request that the RDN and GaLTT do not make any substantial alterations to the existing trail systems until the public, including GaLTT members, have been informed as to the nature of the changes, and had an opportunity to comment on them. GaLTT's eagerness to have the trails updated without consideration of the ecological damage that they do in an effort to have new maps ready before the tourist season appears to me not to be compatible with their mandate "...to preserve sites of environmental ...importance". This is disappointing.

You will have received a letter from Nick Doe a couple of days ago detailing his concerns regarding management planning in the 707 Community Park, including the adjacent recently-acquired parkland and adjoining Coats Marsh Regional Park. I'm currently traveling and unable to give a thorough response. However, Nick's letter contains some incorrect statements that I feel need to be addressed in a timely manner.

Gabriola Land & Trails Trust (GaLTT) is currently cooperating with the RDN Parks to update signage in the parkland described above. The project consists of the installation of cedar posts and signage at currently un-posted trail intersections. Once completed, the project will make the extensive trail system (~40 km of trails) a safer, and more user-friendly recreational area. When planning for this project, GaLTT reviewed the current trail system and made recommendations to the RDN to officially recognize a small number of well-used and currently un-posted existing trails. We also recommended that a few of the lesser-used posted trails be de-commissioned.

Contrary to Nick's concerns, trail-building is most definitely <u>not</u> part of the current project. GaLTT may be interested in having future discussions with the RDN, and possibly with The Nature Trust of BC, about opportunities to improve trail connectivity in the newly acquired parkland. In fact, we have identified a couple of potential short connections that would expand walking and cycling loop opportunities by making use of previously-established and overgrown logging roads. As always, ecological sensitivity is always of utmost importance to GaLTT when proposing new trail routes. However, consistent with GaLTT's previous trail work in RDN parks, we would never consider proceeding with any work without going through appropriate channels and obtaining the required support and approvals. As Nick suggests, the future review of the 707 and Coats Marsh RP management plans would be an appropriate time to have these public discussions.

I will likely respond to Nick directly when I return from holidays. Meanwhile, I wanted you to have this information at your disposal. Best regards, Rob Brockley President, Gabriola Land & Trails Trust

Follow-up to the email below.

I've cc'd Elaine McCulloch, who is our local Park Planner and the RDN staff person who organizes and attends our Parks & Open Spaces Advisory Committee (POSAC) meetings. The next POSAC meeting will be on June 17<sup>th</sup> at 6 pm at the Gabriola Arts Council building (requests to appear/documents should be provided in advance of the meeting so that committee members have a chance to review materials prior to the meeting). At the June meeting the committee will be discussing and making recommendations for project priorities for 2020 within the context of a 5-year plan that considers both budget and staff time constraints, and any current management plans for the park. To bring forward this idea to be discussed, please get in touch with Elaine so she can provide advice about the information to include in the proposal.

Just to throw out some ideas of questions the committee might have of you or staff to help them in their considerations (Elaine can provide more guidance about the level of detail she thinks would be useful for you to provide for this initial proposal): how many holes are proposed, which trails are proposed to be used, whether additional trails would be required or whether existing trails would need to be modified, potential environmental impacts to the park, who would be responsible for course maintenance, potential budget requirements, and how issues such as garbage, washrooms, parking etc. might be addressed. Also whether you're flexible on location (e.g., a different park).

Hi Bill,

Thanks for your email. The 707 is a Community Park and typically something like this would go through the Parks and Open Spaces Advisory Committee (POSAC) for Area B, which has its next meeting in June. The POSAC considers requests from the community about community parks, and helps prioritize RDN staff time and funding with respect to community parks on Gabriola, within the framework of time and funding allotted for Area B. Discussions will be informed by the 707 Community Park Management Plan, which was created based on public input <u>https://www.rdn.bc.ca/cms/wpattachments/wpID2019atID3689.pdf</u>. SUBJECT: Parks Update Report – January to March 2019

#### RECOMMENDATION

That the Parks Update Report – January to March 2019 be received as information.

#### SUMMARY

Parks staff continue to work on projects identified in the 2019 Parks Work Plan and the RDN Operational Plan.

#### Planning and Capital Projects – Key Highlights

#### Regional Parks and Trails

#### Mount Benson Parking Facilities RP-S4-1.20

Parking lot construction is underway with good progress made to date. Site clearing and blasting work are complete, common excavation work, fill placement and storm drainage works are ongoing. Rock blasted from the site will be re-purposed in the design for slope armouring, land-scape features and further processed to become suitable fill material. Variable subgrade conditions were expected and clearing the site did expose areas of unsuitable subgrade soils. Removal and replacement with suitable materials was necessary and a project contingency is in place for such an occurrence. Substantial project completion is anticipated for the end of June 2019.

#### Benson Creek Falls Facilities RP-S2-3.7

A grant application was submitted to the Economic Infrastructure and Innovation Program for the parking lot, bridge and decent to the falls. The Stage 1 submission was approved for funding up to \$103,125. However, the project now has to be approved under Stage 2 which requires more detailed information. The deadline for the Stage 2 application is September 30<sup>th</sup>.

#### TCT Trail Parking and Trail Realignment RP-S4-1.21

Curb stops were added to parking stalls in Phase I Timberlands Rd parking lot. Work continues with BC Hydro on obtaining approval for erection of map sign at the Phase I parking lot. Design of the Phase II parking lot (includes horse trailer parking) and Fortis BC gas line drainage channel crossing will be concluded in the spring and in time for 2020 budget planning. Note: the Trans Canada Trail is now known as The Great Trail (TGT), and work will take place in 2019 on the replacement of all signs along approximately 22 km of TGT.

## Trail from Horne Lake and Heritage Designation RP-S4-1.12

Staff are awaiting Island Timberlands' response to a meeting request to initiate work on dedication of the 1911 Gazetted Horne Lake Road. Recent amalgamation of Island Timberlands and TimberWest operating staff into Mosaic Forest Management has contributed to the delay.

Staff will meet in the spring with Alberni-Clayoquot Regional District staff to explore an approach to engagement with the range of First Nations having potential interest in heritage designation of a traditional First Nations passage across Vancouver Island via Horne Lake.

#### Community Parks and Trails

## EA B - Huxley Community Park Projects RP-S4-1.2

#### Sports Court

The line painting contract has been issued. User groups have been contacted for review of proposed line layout and colours. Work is anticipated to occur the last week of April, weather permitting. The court will be closed for approximately 5 days. User groups will be notified of the temporary closure and notices will be posted at the park and on the RDN website.

#### Phase 2 and 3 Construction Drawings

Final construction drawings have been received and are with staff for review, pending approvals from the Islands Trust for a Development Variance Permit.

#### EA B - Village Way Path

MoTI has confirmed it will support the RDN's revised approach to path design. Final drawings and updated costing will be produced once project budget is refreshed. Work is beginning on an operating plan to establish how the path will be funded, regulated, maintained and replaced. The operating plan is to form part of a MoTI licence to develop the path. It is forecast that a report will be forwarded to the Board in the fall of 2019 concerning acceptance of a MoTI licence, funding of path construction and advancing to tender phase.

#### EA EW/PV - Anders & Dorrit's Community Park Design RP-S4-1.5

Additional information was provided to support the Non-Farm Use Permit application for parking lot construction previously submitted to ALC. No decision has been made by ALC at this time.

#### EA E - Jack Bagley Community Park – Court Placement PR-S4-1.16

The Request for Statement of Qualifications (RFSQ) closed on March 11, 2019. A preferred proponent has been recommended and a fee proposal and scope of work is currently being formalized. It is anticipated that the successful proponent will start the work for the Redevelopment Planning project by the end of April.

#### EA F - Errington Community Park – Master Planning Process RP-S4-1.6

The Request for Statement of Qualifications (RFSQ) was issued on March 1, 2019 and closed March 15, 2019. Proponent evaluations are underway. The preferred proponent will be recommended by mid-April 2019; fee proposal and scope of work will be formalized by end of April 2019. Detailed design and costing to be complete by end of August 2019.

#### EA G - Little Qualicum Hall Renovation RP-S2-3.6

The Building Permit for upgrades to the hall was issued on March 19th and preparations for construction are underway.

### EA H - Dunsmuir Community Park Development RP-S4-1.7

Construction deficiencies will be completed this spring including planting and fine grading.

#### General Updates

#### **Registry and Mapping**

Shape files for all community park acquisitions have been completed with work continuing on the creation of Regional Park and trail shape files. Community Park planning maps have been completed for all electoral areas and are being distributed to POSACs over the course of winterspring 2019. The park acquisition registry system is now serving development of the RDN's asset management system.

#### **Operations – Key Highlights**

#### General Service Calls

Staff was heavily involved with clean-up of areas impacted by last December's windstorm. Clean-up of some areas extended into March due to weather conditions. Work on the Arrowsmith CPR Trail is still required due to earlier snow conditions.

Resident request calls and emails resulted in 10 work orders relating to hazard tree issues that required staff investigation, assessment, and in some cases removal of trees.

#### Park Inspection and Service Software RP-R2-4.6

Inspections were conducted at 147 park properties during the period of this report. Faults discovered during an inspection are often rectified at the time if minor or moved into the work order system if additional follow-up or other resources are necessary. Inspections help to identify items for future budget considerations and monitoring the condition of park assets.

#### Parks Programming

Trail Running program slated for February 24 was rescheduled to April 7 due to snowy and icy trail conditions.

Programming for Spring and Summer 2019 completed, with the Active Living Guide featuring three pages of parks information and Outdoor Recreation programs.

#### Park Use Permits

Area A – No permits issued for this quarter.

- Area B No permits issued for this quarter.
- Area C No permits issued for this quarter.
- Area E No permits issued for this quarter.

Area F – DFO was issued a permit to do road and side channel (Clay Young Channel) maintenance on March 21, 2019. Mid Vancouver Island Habitat Enhancement Society was issued a permit to do a tour of the Clay Young Channel on March 25, in conjunction with the Brant Festival.

Area G – BC Conservation Foundation was issued a permit to do an educational tour of Little Qualicum Estuary Regional Conservation Area in conjunction with the Brant Festival.

Area H - No permits issued for this quarter.

#### FINANCIAL IMPLICATIONS

The projects outlined in this report have funds identified in the 2019 Budget. Electoral Area projects are funded through the associated 2019 Community Parks Budget and in some cases are supplemented by Community Works Funds or grant funding. Regional Parks projects are funded through the 2019 Regional Parks Operational Budget or the Regional Parks Capital Budget.
