Port Alberni Councillor Ron Paulson and Director of Parks, Recreation and Heritage, Willa Thorpe were in attendance to express their appreciation to the Regional District of Nanaimo and the City of Parksville for accommodating the Alberni Valley Bulldogs and Junior A hockey teams at the Oceanside Place facilities when Port Alberni's multi-plex facility was shut down. Kim Burden, Executive Director and Corry Hostettert, Economic Development Coordinator for the Parksville and District Chamber of Commerce were in attendance to apprise the Committee that as a result of the Jobs Creation Project Grant that was awarded to the Parksville & District Chamber of Commerce, the Oceanside Initiatives office has opened and staff has been hired. Kevin Elder, Superintendent of Schools, Ron Amos, Secretary Treasurer, and Chris Dempster, General Manager of Operations from School District 69 were in attendance to seek support for the Board of Education's motions to enter into a joint-use agreement with the Regional District of Nanaimo and support, in principle, for construction of an eight-lane competition track at Bellenas School.

It was moved and seconded that the Regional District of Nanaimo support, in principle, the recommendation of the Ballenas Track Renewal Steering Committee to plan for the construction of an eight lane competition standard track at Ballenas Secondary School, with the final decision to come after reports from the School Board on all implications, including funding of both the construction and the ongoing maintenance of the track.
