Dear Chair Ian Thorpe and all RDN representatives:

The 707 community park on Gabriola Island is a large area, with vast tracts of underbrush and many slash piles that pose a significant fire risk throughout late spring and summer. With limited cell coverage, little road access, and limited water, firefighters cannot easily get to the park to handle emergencies. Allowing camping in this park is unwise and could easily have disastrous effects on Gabriola.

I therefore write to support agenda item 13.1 at this Tuesday's Board meeting:

"That notwithstanding "Regional District of Nanaimo Park Use Regulations Bylaw No. 1801, 2019", homeless camping in the 707 Community Park in Electoral Area B be immediately temporarily prohibited until park conditions and wildfire risk due to homeless camping is assessed, and a recommendation received as to whether or not, based on park conditions and wildfire risk, homeless camping should be prohibited in all or some areas of the park either permanently or seasonally, and a mitigation plan developed and implemented if appropriate."

I urge representatives to seek other solutions to meet the housing needs of the Gabriola homeless population, perhaps, in the interim, by allowing camping in Descanso Bay Regional Park campground.

When I first heard that camping would be permitted in the 707 (on Gabriola) I thought for sure that had to be incorrect. But it's not and I am astounded.

As a 20-year resident of Gabriola, I have cycled and walked those paths frequently. I once felt safe in doing so. I have picked up trash left by illegal (now legal) campers. I will no longer walk alone in that park, although I will cycle. I don't feel safe. I'm a 70-year old woman, and the potential for an encounter with a "camper" scares me. If such an encounter went bad the likelihood of being able to summon help is slim. Add to that, and more importantly, the potential for fires is huge. And that scares all of us.

It's an extremely large park with limited and difficult access, and honestly how would you get water into any of those places? Has the RDN asked themselves that question? Never mind a pumper truck. There are no real roads. It is already a fire hazard. And campers start fires, there is little else that needs to be said on that topic.

If a walker or biker came across a fire there would be the added difficulty of getting through to help, given the extremely poor cell coverage. And to expect our volunteer fire department crew to take on such the task of tackling a fire in the 707 is beyond unreasonable.

With all due respect, have the people at the RDN who passed Bylaw 1801 ever been to Gabriola, or walked through the 707? There are no facilities at all, which begs the question where are campers putting their "waste?" Where are they getting water to douse their illegal fires, as no outdoor fires are permitted at all on Gabriola?

Dear Chair Ian Thorpe,

I understand that the next RDN Board Meeting will be discussing the acceptance of homeless camping in Gabriola Island's 707 Community Park. This is a bad idea for many reasons but mostly from a health and fire hazard perspective.

We have all seen the disaster homeless camping brought to Vancouver's Oppenhiemer Park through fires and sanitation problems. This is in spite of the close proximity of portable toilets and police, medical and fire services. While the numbers expected in the 707 Park would of course be considerably less, these hazards are relevant. Some of the mental and addiction issues found in Oppenhiemer Park must be assumed in the Gabriola homeless population as well.

I have already experienced the delight of taking home a dog who has found and rolled in human excrement while walking through Gabriola's woods. Parkland in the vicinity of homeless campers will become a no-go-zone for walkers and their pets for this reason. The 700 acre park is served by a complex narrow trail system which is unsuited for motorized access. Police, medical and fire response will at best be severely restricted unless remedial road construction is done throughout effectively reducing its appeal as a nature park. The breakout of a fire in the 707 Park during the fire ban season will threaten the entire island. Policing the campers in the park will have to be an 24 hour job for a RDN park warden.

The Descanso Bay Regional Park is already equipped with pit toilets and fire sites. During fire bans, the park is easily patrolled and is completely accessible to all types of emergency vehicles. Yes there is no potable water in this Park but there is non in the 707 Park either. If the RDN assumes its mandate includes sheltering the homeless, there has to be a better solution than allowing them to camp wild in Gabriola's wilderness parks. Homeless camping in the 707 Community Park is unacceptable.

I am a resident of Gabriola. With our increasingly dry climate, wildfires are a concern. Fire bans are frequent - this includes shutting down the use of power tools, as well as open fires. The posted fire hazard is 'high' for most of the summer, and usually spikes to 'extreme' at some point during the summer months. Virtually everyone who lives here has this worry in the back of their minds - what happens if we have more summers like 2017 and 2018, when the whole province was going up in flames? What if help is not available from the RDN because fire-fighting equipment is needed elsewhere? Our volunteer fire department could be quickly overwhelmed.

For this reason, I am urging that all camping in the 707 CommunityPark and the Cox Community Park be banned. These parks are large, heavily wooded, and would be hard to monitor. Hi there,

At the behest of the Gabriola Volunteer Fire Department, people I know are emailing you about prohibiting camping in the 707 community park.

Gabriola does have a population of homeless people that live in the park, and while the justifications for requesting this ban have sound logic - fire risks, difficulty with rescue operations, no cell service - I fear many will be using this as an excuse to take punitive measures against those people and dispell them.

There is a vocal aspect of the community that bases their decisions on biased views against homeless people - no, houseless people. Their home is indeed the island of Gabriola, but given the discrimination here, the lack of housing, and jobs to pay for housing, they are unable to attain lodging. Here, the income discrepancy is drastic, obvious in the attitudes of high income people migrated here from cities like Vancouver, or from the United States, and it's becoming more and more apparent, and not what many of us in this community want.

It is my very strong belief that if the decision is indeed made to prohibit camping in the park, it is imperative to have a plan in place for supporting the individuals displaced, and either providing them lodging or providing them with an alternate site they can erect their tents safely.

To root people out of a public park and force them to hit the streets in Nanaimo or elsewhere while a global pandemic threatens their health and safety, a direct violation of human rights, is abhorrent and not what our community stands for.

To reiterate, I believe the health and safety of these people is important, and the fire risk is real, and I know the GFVD have had difficulties with operations in the 707, and the most likely outcome is that camping will be prohibited. That is what it is. However, if that is indeed what it is, it's equally important to the health and safety of those individuals to treat them with respect, and have somewhere for them to go. Perhaps the camp grounds (closed to tourists during this time), other parks close to the village core, or perhaps temporary housing agreements with the owners of the houses on this island that sit empty for 10 months a year.

I urge the people making this decision to weigh the human cost of displacing houseless people during this pandemic as the monetary cost.

I thank you for taking the time to read my message, and to consider what I have said. Please don't leave anybody behind during this terrifying time.

The 707 is an extremely large park with already limited and difficult access for our firefighting crews and equipment.

The thick underbrush and slash piles alone are an extreme fire hazard in normal circumstances, let alone with the added risk of campers being neglectful.

In the late 90's there was a fire in the 707 that engulfed five acres of land. It took the fire department over 18 hours to put it out with no outside help from forestry.

Due to the extremely poor cell coverage in the 707 we often have a difficult time locating people in a emergency.

Being an island Gabriola has no mutual aid agreements so in most emergencies we are on our own. Forestry will come when they can but their resources and ability to respond is also limited.

We are working hard with forestry to keep access to the 707 open but at this time the park is still not safe for any type of camping due to the potential of wildfire.

We are asking for your support by writing a letter to the Region District of Nanaimo requesting the 707 be excempt from their Bylaw 1801 which allows people to camp in selected parks.

Dear Board Members,

I am writing to you in my capacity as an individual Trustee on the Islands Trust and as a community member on the island now called Gabriola, in the territory of the Snuneymuxw First Nation.

I am also a recruit firefighter with the Gabriola Volunteer Fire Department, and would like to add my support to the motion calling for an assessment of homeless camping in the 707 Community Park.

Here's the central issue: The federal government and, for decades until very recently, the provincial government here in British Columbia, abdicated their responsibility to address core housing needs. Now local governments and communities are facing a housing crisis without the tools or resources to help the people most in need.

We could all be working together, as we have during the pandemic: Put the emphasis on health and science and provide what everyone agrees is the cornerstone of poverty action: safe and secure housing.

There are signs we are heading in that direction. This past weekend, the BC government announced it will use hotels in Vancouver and Victoria

to house homeless people, and I want to thank you and RDN staff for partnering with the Gabriola Local Trust Committee and other area municipalities on a UBCM grant application for a Poverty Reduction Strategy and Action Plan.

But we are not there yet. Gabriola has a very high proportion of people and families living in poverty, and many of the solutions, including adequate mental-health and economic support, feel far away for people sleeping rough right now.

What to do in the interim is the challenge in front of us, and I hope kindness and care for all our neighbours can guide our actions.

In terms of the 707 park, it has many issues for first responders in an island community without the redundancies of larger, more connected centres. From access for vehicles to inconsistent cell and radio communications to the very real dangers of interface wildfires, we need to make sure we aren't making things worse for everyone involved.

I agree with Director Craig and Chief Sprogis that an assessment is required, and I look forward to working together to get support and funding from senior levels of government to implement long-term housing solutions for our neighbours and communities.

This email is in regards to the RDN allowing camping in Gabriola's parks.

I have walked or jogged many, if not most of the trails and I concur with Fire Chief Sprogis that the park, because of it's size and heavy vegetation/growth would be impossible to monitor anyone camping here.

The trails are such that a fire could be started through cooking, keeping warm or lighting cigarettes/joints and our fire department would NOT be able to get to it. Smoke coming from said fire would be hard to trace where it is coming from unless there is absolutely no wind and then to try to find the fire would be very difficult. Just how are the fire fighters suppose to run into site accessed by narrow deer trails with all their equipment on and drag equipment behind them? The RDN is putting our lives and property at risk with this decision. Or what about first responders carrying all the equipment they would have to anticipate they might need? Someone will die.

Gabriola been described as a Mediterrean climate so we get less rain than Nanaimo. With less rain, it gets tinder dry here quicker and for longer time periods. As well, our water supply is limited even at the best of times.

Anyone using this property to camp and using drugs and happened to OD would likely die as they could be too hard to find. Most camping drug users would position themselves where they would not be seen and they would not be found in time to prevent an over dose.

We have limited fire fighting and first responders services and having them combing through the bush in search of campers is not properly using their abilities. Sending people over from Nanaimo to track the campers and TRY to get them to pack up at 9 a.m. isn't the answer either, as these people would likely get lost and would require Island people to look for them. Truly now...how realistic is it that the campers would pack up all their gear & be out by mid morning? Sure...and pigs fly.

During this time of Covid-19, small communities want non residents to stay away because of limited resources. It is the same with homeless campers in our forests...we have limited resources to track their movements and try to keep us and them safe.

As I said above...having the homeless camp on Gabriola is putting our lives and property at risk and their lives at risk. It is not even a good temporary solution. Be realistic....the homeless need permanent homes...not always temporary solutions governments come up with.

Should Gabriola need evacuating, it would be extremely difficult to evacuate residents and visitors

It is the expert opinion of our Fire Chief and his staff that allowing camping in the 707 at the moment, and going forward, presents a serious and unacceptable risk to the island and its population, as well as to the campers themselves.
