Engagement Objectives

To provide information to First Nations, provincial agencies and affected local governments.

- To make information readily available to interested public and stakeholders.
- To respond to input from public, stakeholders, First Nations, and affected local governments.

Decision

The proposed amendment will incorporate the recommendations of the French Creek Active Transportation Plan (ATP) into the "Regional District of Nanaimo Electoral Area G Official Community Plan Bylaw No. 1540, 2008" (OCP). The proposed OCP amendment will reference the standards and network established in the ATP to provide direction to the RDN in construction of active transportation facilities or desired community amenities with development.

Key Topics for Engagement

- 1. Provide information about the proposed changes to the OCP.
- 2. Identify any concerns with the proposed OCP changes and provide alternative approaches.

Relevant Background

On March 23, 2021, the RDN Board approved a Terms of Reference for an OCP amendment to incorporate active transportation planning. The RDN engaged ISL Engineering and Land Services to conduct a review of existing active transportation conditions in French Creek, engage the community on the conditions, and propose recommendations for an amendment. The ATP was prepared through two phases of community engagement to establish an active transportation network. The first phase established how residents travel within French Creek and barriers to travelling actively. The second phase of engagement confirmed the draft network and route options established through the first phase and the review of roadside conditions. Both phases primarily used the website www.getinvolved.rdn.ca/think-active-transportation to collect feedback through surveys and public discussion forums due to restrictions on gatherings during the COVID-19 pandemic. The second phase also included a virtual question and answer period as an opportunity for more discussion.

The proposed amendment will include both text and map amendments. A new section will be added to the Improved Mobility goal to address the active transportation network specifically. Existing policies under Section 9.4 Walkways, Bikeways, and Trails will be retained and clarified. The new section will reference the active transportation facility standards established in the ATP. The mapping amendment will include the active transportation network on Map 8.0 Mobility Options.



Promise to the Public/IAP2 spectrum

In the preparation of the ATP, the public had the opportunity to be involved in the creation of an active transportation network based on the Consult level of participation on International Association of Public Participation (IAP2) spectrum. This was balanced with the technical review of existing conditions for active transportation and selecting central routes with the greatest amount of benefit for residents and commuters through French Creek. The IAP2 Consult level of engagement includes listening and acknowledging concerns and aspirations, and providing feedback on how public input influenced the decision. This level also seeks public feedback on drafts and proposals.

Given the ATP is complete, the public participation goal for the OCP amendment will also be to consult on how the ATP is incorporated into the OCP. The public may comment on the proposed amendment until the public hearing on the bylaw. The RDN Board may direct changes to the bylaw based on public feedback prior to final adoption, provided density or land use is not affected after the public hearing.

Engagement Considerations

Requirements for consultation on OCP amendments are outlined in section 475 of the Local Government Act.

Public Hearing: A public hearing will be held for the proposed OCP amendment bylaw.

Key Messages

- To implement the ATP and reflect the network in RDN decisions on land use and infrastructure, the ATP must be included or referenced in the OCP.
- The engagement on the amendment reflects how the ATP recommendations will be included in the OCP.
- The OCP amendment will enable the RDN to apply for grant funding for active transportation route in the ATP and require active transportation improvements associated with development approvals.
- The RDN will need to consider other options for implementation, such as the ability of existing service
 areas to accommodate additional construction and maintenance costs or establishing a new service area
 to address active transportation.

To answer these questions, we will measure engagement as follows:

- 1. Tracking the responsiveness of the feedback received.
- 2. Tracking the quality of informed feedback received Was the information received effective in shaping the decisions made.



Closing the Loop

As an on-going practice, regular updates will be posted to the Get Involved RDN webpage, providing current information and next actionable steps of the engagement process. Input from stakeholders and the public will be compiled and posted on the Get Involved RDN webpage and will be summarized in a report to the Board.
