

2022 YEAR IN REVIEW – DRINKING WATER & WATERSHED PROTECTION

RECOMMENDATION

BACKGROUND

The Regional District of Nanaimo's (RDN) Drinking Water and Watershed Protection (DWWP) program action areas are organized into four related themes: Water Awareness and Stewardship; Water Information and Science; Water-Centric Planning and Policy Support; and Water Collaboration.

Highlights of the program accomplishments in 2022 under each theme are presented in **Attachment 1**, along with the associated progress indicators (for the full list of indicators please reference the *DWWP Action Plan 2020-2030 Section 7.1*¹, excerpted in the table below).

- Initiate the Phase 3 Water Budget for the Cedar-Yellowpoint region
- Initiate the Ecological Accounting Process Partnership
- Develop communication material for Water Supply Resiliency Project (in partnership with LRP dept.)
- Initiate a Regional Climate Change Assessment (in partnership with LRP dept.) as per recommendations in the Regional Strategy for Rainwater Management
- Continue water monitoring and reporting across the region.
- Expand the Demonstration Site and Interpretive Signage Program
- Refine Lake Site Monitoring through equipment upgrades and staff training
- Expand Watershed Field Trips to pre-COVID attendance
- Continue equipment upgrade program
- Deliver curriculum connected school programming for freshwater stewardship with community partners.
- Replace 10-year old turbidity meters as part of asset management plan for the Community Watershed Monitoring Network.
- Continue offering water stewardship rebate funding and stewardship seed funding.
- Continue facilitating implementation of regional watering restrictions framework with water purveyors.
