Hello RDN, the revised link still doesn't work...

And as an addendum to my submission, in which I ask that RDN Do Not Approve, the **Federal government and Other Canadian agency last week declared that this wildfire season is now the most unprecedented in Canadian history**, [ as if last year and 2017 and 2019 weren't bad enough] . I strongly advise the RDN to deny this multi-fronted CO2 and nitrous oxide venture not to proceed. For our environmental and safety concerns, it is close to ecocide adding this to our problems. We need to focus on reversing this trend and turn this patch of Crown land into a protected mini-grassland for ground based wildlife.

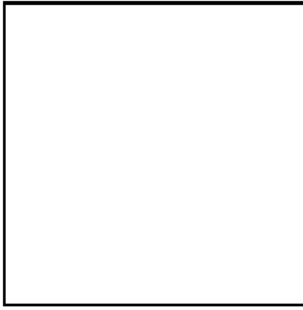
