

GROWING COMMUNITIES FUND JULY 25, 2023

PLEASE NOTE THAT RECOMMENDATIONS WERE VARIED BY THE COMMITTEE

RECOMMENDATIONS

- That the Board confirm the allocation of the Growing Communities Fund as presented, OR
- 2. That the Board provide alternate direction to staff in relation to the allocation of the Growing Communities Fund.

BACKGROUND

The Regional District of Nanaimo (RDN) received a letter signed by Anne Kang, Minister of Municipal Affairs in relation to the \$7,929,000 one-time Growing Communities Fund (GCF) grant included as Attachment 1. The letter identifies eligible costs as one-off, incremental and should accelerate the delivery of capital projects (not replace existing capital commitments), including feasibility studies or other early-stage development work. The funds are to be expended within five years of receipt (by March 31, 2028).

The BC Government has also published a Frequently Asked Questions for Regional Districts which is included as Attachment 2. Additional information includes that the GCF was intended to assist the Board in addressing regional priorities for actual infrastructure and other eligible costs and not meant to be reallocated back to electoral areas based on the Ministry allocation formula.

In order to support the Board's deliberations on the application of the funds, staff prepared an analysis using a multi criteria evaluation tool intended to prioritize projects from the Board's 5 year financial plan. The criteria used in the tool is included in Attachment 3. Naturally, the Board may use any methodology that does not violate the criteria communicated by the Minister and the ministry. The following table provides staff recommendations including the value assigned using the evaluation tool for the GCF grant allocation:

The four projects highlighted in yellow about have changed as follows from the June 27, 2023 report:

- The Descanso Bay Wharf Service is a new project added,
- The weighted criteria score for the Board Chambers upgrades and reconfigurations has been added and more details will be provided in a separate Board report,
- Detail about the name and weighted criteria score have been added for Rollo McClay Park improvements and Extension School Lands.

FINANCIAL IMPLICATIONS

The allocation of the GCF to these projects provides funds for currently unfunded projects, reduces the requirement to borrow, reduces the use of Community Works Funds or reserves and may also result in the reduction in the tax requisition. The following table summarizes the impacts for the recommended use of the GCF:

For each of the projects, the value allocated to each Municipality and Electoral Area was determined by identifying which service the project belongs to and which Municipalities and Electoral Areas participate in that service. Using the 2023 Revised Roll Assessments, values were assigned to each Municipality and Electoral Area. The following table compares the total value for the recommended projects of \$7,605,388 to the Funding Formula:
