Hi Stephen,

Thanks for hanging around long enough for me to get outside and have a brief chat with you.

The more I think about this proposal the less I approve of it.

1. I mentioned the noise factor to you. We already have ATV users cruising up and down Melrose regularly. They, along with the dirt bikes with their mufflers knocked out, make up a good portion of the noise pollution we already endure around here.

2. Then there's the air pollution factor. The exhaust from quads I've been around really stinks. I have sensitive lungs to pollution like that. When the air pressure conditions are just right, I can "TASTE" the less-smelly but still-harmful exhaust from Highway 4. When I rinse out my mouth and gargle with water, the taste goes away for a while. Repeat as necessary until the air pressure changes. Enough is enough, already!

So, if you add in a regular-to-constant supply of ATV noise and exhaust into this corridor area, on top of the wood stove and garbage-burning or slash-burning smoke--well, I think my neighbours would agree that our quality of life just went down another notch.

Further up Melrose, just past the Christmas tree farm is a large pit they have even used for a rifle range. Maybe that one could become available. There are ATV trails uphill from us. Why can't that area be the training area? It's already there and as realistic as the real thing, because it is the real thing, it would seem to me. Or else, up Cook Creek or somewhere besides a populated area like Melrose/Whisky Creek.

Please take me seriously. I think most of my fellow residents would agree with me.

Hello

My name is Jim Moir and I fully support this application and the opportunities that come with it. I recently moved to Vancouver Island (end of February 2023 to the Campbell River area - about halfway between Campbell River and Comox Valley). I am a Canada Safety Council Chief Instructor for ATV (since 2009), UTV (since 2010) and Snowmobile (since 2017) profiles. I have been instructing since 2004 when I was in the RCMP before later becoming a Chief Instructor. I can deliver instructor training as well as one day operator safety training courses to the general public, industry and various levels of government agencies.

I was in attendance at the Comox Valley ATV Club AGM Meeting where I met Oliver Sayah from the club who is trying to create an ATV/UTV training and practice area.

I believe this is an excellent opportunity for the ATV/UTV community and the various levels of government as well Mosaic Forest Management to work together to create a safe training and practice space such as this location. Currently to my knowledge there is no such designated location anywhere in BC that is designated for ATV/UTV training or practice. I have delivered training all over the Province of British Columbia to the general public, industry and various levels of government agencies. Many times it has been a challenge to locate such a training location to train and practice safe operating skills with the candidates wanting to learn safe riding practices.

I have had a lengthy phone conversation with Oliver regarding what he is trying to secure on behalf of Vancouver Island ATV/UTV users. At no time did Oliver note there was going to be a raceway. In your brief notes above it is noted "The proposed racetrack and accessory campground ..." From my understanding there is not going to be a raceway, rather a training area for instructors to train candidates and where people/families etc can attend to practice in a safe learning environment for their safe riding and skills. Especially for families with children.

I am a long time resident and ratepayer of the Comox Valley, as well as being an active member of the Comox Valley Atv Club, I am whole-heartedly in favour of this application for a temporary land use permit.

This proposed practice and training facility should be embraced and supported by the greater community. With the geographical location, not only is it situated far away from any residences, it also sits adjacent to forest lands, which offer a plethora of riding terrain, with minimal noise pollution or impacts, to local residents.

This is an excellent opportunity to develop and provide a safe location where all ages of Motorsports enthusiasts can better hone their skills, through practice, training, and education.

Another point lost with the anti-offroading types that roam amongst us, is that we, as a fully legal recreational choice, generally have the financial means to create economic stimulus to the local region. Hello,

I prefer not to register to provide input but do live in the area of the permit application ([REDACTED]) and wanted to mention two areas of concern.

While I support the site area and proposed use, I have a significant concern around fire risk and wildfire mitigation. While the site may appear and feel fairly remote, the dense forest area surrounding it leads to my and others doorsteps. The adjacent area F neighbourhoods of Melrose and Meadowood are already considered high to extreme risk if a wildfire were to break out.

As the proposal proceeds I'd like to see the proponent provide to the RDN a wildfire risk/avoidance plan that could include; adding signage letting users/campers know the area is exceptionally high risk, proposing a threshold for closing the facility during high risk periods, providing official feedback or endorsement from the BC Wildfire office in Errington who would be the only department legally able to respond if a fire started due to the crown land location. Directly asking for comment from Coombs-hilliers fire department would also seem prudent.

The similar recreation area on the other side of the highway used by Dirtbikers has generally been a success as they shut down during dry summer months and their presence keeps out more bothersome homeless encampments. However the increased (often speeding) traffic has been an issue along the residential strip of Melrose. It would be appreciated if the proponent was directed to make all promotional material indicate that access be through the shorter route coming off Claymore.

Hello, I made a phone call submission very recently to the RDN relating my history and personal usage of this parcel, and a submission of objection to the Ministry of Forests, on file with them. To keep this submission concise...I object to the application, there is a seasonal wetland at the far eastern end, and until the recent intrusions of ORVs/Trial Bikes from across the hwy. , some crossing illegally, this former gravel operation site WAS returning to nature. I have been using and finding some solace in this place for several decades , watching nature slowly return after the building of Highway #19. This writer had hoped that a Nature Trust would intervene and promote the establishment of a protected flat ground bird grassland, reptile and raptor and other species that migrate into here. I do believe that someone had entered a request on my behalf to M.O.F. This request now falls upon other authority. The intrusion of ORVs has ruined that. M.O.F. has stated that one half of the area would be fenced off to recognize the wetland, but I question how that will be enforced and monitored and repairs made? Safety issues? Current user groups [self propelled, hikers] have seen our quiet pristine forested and open areas being usurped and unusable due to the other increased trail network of motorized vehicles adjacent to this Lot. Now I fear that current retreats are no longer possible, parking may be an issue, and whereas sky viewing/dark sky was possible, and migratory birds visiting, this could be threatened by any "allowed overnight habitation, generator useage, artificial lighting and noise, music, etc" . The fossil fuel portion of this proposal is unacceptable. The applicant from Richmond wishes to organize convoys of Trucks/trailers/ATVs , increased ferry useage to come over here and burn fuel? No, that kind of 'recreational activity' that further violates our goals of atmospheric renewal and a lessening of carbon etc. pollution should not be encouraged. There are already complaints from the residents to the north of this area, combined with other unfavourable activity's and unpermitted uses. I understand that residents of Melrose south of here also have concerns and objections. I strongly suggest that the RDN deny this application and lean towards a protected status and renewal of wilderness and peaceful nonpolluting considerations of these rare plots of crown lands.
