## **BYLAW NO. 1845.01**

# A BYLAW TO AMEND THE DEVELOPMENT APPLICATIONS NOTIFICATION PROCEDURES AND FEES BYLAW

WHEREAS the Regional District of Nanaimo established the Development Applications Notification Procedures and Fees Bylaw No. 1845, cited as "Regional District of Nanaimo Development Application, Notification Procedures and Fees Bylaw No. 1845, 2022";

AND WHEREAS the Board of the Regional District of Nanaimo wishes to update the Schedules in Bylaw No. 1845 to reflect the correct department name and to update the servicing review fees;

NOW THEREFORE the Board of the Regional District of Nanaimo, in open meeting assembled, enacts as follows:

#### 1. Amendment

"Regional District of Nanaimo Development Application, Notification Procedures and Fees Bylaw No. 1845, 2022" is amended as follows:

- a) By amending Section 1.0 of Appendix A to add the definition of Water Services, as follows:
  - "Water Services" means the Regional District of Nanaimo Water Services department that is responsible for operation and maintenance of all Regional District of Nanaimo water and sewer collection services.;
- b) By amending Section 16.1(b) of Appendix A to add the words "that will become part of Water Services' infrastructure" at the end of the sentence;
- c) By amending Section 17.3 of Appendix A to remove the words "development cost charges";
- d) By deleting Table 3 in Schedule A-2 of Appendix A and replacing it with the Table in Schedule 'A' attached hereto and forming part of this bylaw; and
- e) By deleting Table 1 in Schedule A-3 of Appendix A and replacing it with the Table in Schedule 'B' attached hereto and forming part of this bylaw.

### 2. Citation

This bylaw may be cited for all purposes as "Regional District of Nanaimo Development Application, Notification Procedures and Fees Amendment Bylaw No. 1845.01, 2023".
