It was moved and seconded that the 2024 - 2028 Financial Plan be revised to include the Rivers Edge Water Service Area smart water meter replacement project executed in 2024, and that pending approval from the Union of British Columbia Municipalities that \$70,000 of Electoral Area G Community Works Funds be allocated for this project rather than spread over 5 years.

River's Edge Water Service Area Water Supply

It was moved and seconded that:

Whereas the Ministry of Water, Land, and Resource Stewardship manages the Water Sustainability Act, Water Sustainability Regulation, and Groundwater Protection Regulation;

And the River's Edge Water Service Area (WSA), operated by the Regional District of Nanaimo (RDN) and serving 157 properties, has identified a serious pending water quality problem with the water supply to that WSA due to an increasing trend of chloride concentration that will result in the supply water becoming non-potable in the foreseeable future:

And that the probable causes of the problem have has been identified by a professional hydrogeologist to be contamination from an underlying aquifer that is caused by the WSA drawing its water supply from a single location in the overlying aquifer, and high water use drawing down the aquifer;

And that despite the fact that the River's Edge Development (RED) includes Statutory Building Scheme (EW14859) over all 157 properties listed as a charge on the Land Title Certificate which specifies that no private well shall be drilled on any lot", at least 10 properties in the RED that are part of the WSA have "prohibited" private wells and extract water unrestrictedly from the same aquifer that the WSA supply wells are drawing from, and some of these wells are in close proximity to the WSA's production wells;

That to support the long-term health of the aquifer supplying the WSA, the RDN Board requests that the Ministry of Water, Land, and Resource Stewardship deploy the regulatory tools identified in the BC Drought and Water Scarcity Response Plan (2023) to restrict the use of the

unauthorized private wells whenever the WSA is subject to RDN-imposed Watering Restrictions.
