### RECOMMENDATION

That the Board endorse the following projects for grant applications to the Canada Community Building Fund - Strategic Priorities Fund, and support overall grant management activities:

#### Capital Infrastructure Stream

- Errington Firehall #2 Replacement
- Departure Bay Pump Station Upgrade
- Hammond Bay Forcemain Twinning Project

# **Capacity Building Stream**

Snuneymuxw First Nation (SFN) Asset Management and Infrastructure Planning Project

## **BACKGROUND**

The Strategic Priorities Fund (SPF) is one of three funding streams delivered through the Canada Community-Building Fund (CCBF) in British Columbia, formerly known as the Gas Tax Fund.

The SPF is an application-based program that provides funding for strategic investments. This fourth intake of the SPF program will see an investment of up to \$125 million to support infrastructure and capacity building projects in communities across the province and is administered by the Union of British Columbia Municipalities (UBCM). The SPF program can contribute up to 100% of the cost of eligible activities to a maximum of \$7 million.

All local governments outside Metro Vancouver are eligible to apply. According to the UBCM guidelines, local governments are also able to submit applications on behalf of an Ultimate Recipient:

"A local government may sponsor an application for an Ultimate Recipient. This will count as one of that local government's application and the local government will be responsible for ensuring that all obligations under the CCBF SPF program are met – including program and project reporting".

An Ultimate Recipient is defined as — a local government; a non-municipal entity, including for-profit, nongovernmental and not-for-profit organizations located and operating in British Columbia; and BC Transit. This will count as one of that local government's applications.

Applications intakes are under two streams:

- Capital Infrastructure This stream provides grant funding specifically targeted for the capital costs of local
  government infrastructure projects that are large in scale, regional in impact, or innovative and support the
  national objectives of productivity and economic growth, a clean environment and strong cities and
  communities.
- Capacity Building This stream provides grant funding for local government capacity building projects, including asset management, long term infrastructure planning and integrated community sustainability planning that support national objectives and are large, regional in impact or innovative.

A Regional District may submit up to four applications, with a maximum of three under the Capital Infrastructure stream and one under the Capacity Building stream. The deadline for applications is September 12, 2025.

Staff utilized the following approaches in their analysis to develop their recommendations:

- A multi criteria evaluation tool (included in Attachment 1) intended to prioritize projects identified by RDN staff; and
- Identifying whether a project supports the objectives within the SPF large in scale, regional in impact and innovative - and CCBF's national objectives of productivity and economic growth, a clean environment and strong cities and communities.

Grant applications and funding levels for the following projects are recommended by staff:
